RE: File Number MCI 17-088

This is in response your access request under the *Freedom of Information and Protection of Privacy Act* (FIPPA) for the following:

"The ON PNP drew at least a thousand people from the Federal Express Entry Pool in July of 2017, for foreign national within the Information Technology and Communication (ITC) Sector. Only candidates with the 'most recent' Express Entry profiles was invited. The ON PNP did not draw all applicants in the Federal Pool within the ITC occupations that complied with the requirements above. Instead, only applicants that were entered into the Federal Express Entry pool after a certain date were screened.

I am looking for final copies of any document including policies, briefing notes and e-mails that discuss the time parameter by which the draws were conducted. "

The Ministry of Citizenship and Immigration has made a decision to grant full access to your request made under the *Freedom of Information and Protection of Privacy Act* (Act). Please see attached the record responsive to this request.

Please Note: The search conducted in the week of June 26, 2017 was targeting candidates with work experiences in the Information and Communications Technology (ICT) sector. In addition to these occupation-specific searches, the OINP will continue regular searches of the Express Entry pool for candidates who qualify for the HCP Stream with a CRS score of 400 points or more. Prospective applicants to the HCP Stream are encouraged to create a new profile in the Express Entry system to make it easier for Ontario to identify their profile during its search in the federal government's Express Entry pool. We encourage you to visit our website http://www.ontarioimmigration.ca/en/pnp/OI_PNPNEW.html frequently for updated information.

Section 57(1) of FIPPA requires fees for processing requests and Reg. 460, subsection 6, prescribes fees to be charged to prepare records for disclosure (i.e., search and severing time at \$30.00 per hour) and to photocopy records (i.e., at 20¢ per page). No fees apply to the processing of your request.

Section 29(1)(b) of the Act requires that the requester be provided with the name and position of the person responsible for making the decision. This decision was approved by Michael Reid, Assistant Deputy Minister, Immigration Selection Division.



- 2) The file number listed at the beginning of this letter;
- 3) A copy of this letter; and
- 4) A copy of the original request for information.
