Re: Your Request for Access to Information Under Part 2 of *The Freedom of Information and Protection of Privacy Act:* Our File No. 2020 – E 113

On June 25, 2020, Manitoba Economic Development and Training received your request for access to the following information:

"Please provide list of all the occupations or NOCs for which invitations were provided in the Strategic Recruitment Initiative from 1 Jan 2020 - 24 June 2020. Please also include the number of invited in each NOC."

I am pleased to inform you that your request for access to these records have been granted in part. Please find the attached records for your review. As required by subsection 7(2) of the Act, we have severed information that is excepted from disclosure and have provided you with as much information as possible.

Please note that NOCs with values between 0 and 5 are not released. This is done to prevent individuals from being identified when Manitoba Provincial Nominee Program data is compiled and compared to other publicly available statistics.

Access to the remaining records falls within the following exceptions to disclosure in The Freedom of Information and Protection of Privacy Act:

Privacy of a Third Party

Disclosure harmful to a third party's privacy

17(1) The head of a public body shall refuse to disclose personal information to an applicant if the disclosure would be an unreasonable invasion of a third party's privacy.

Disclosures deemed to be an unreasonable invasion of privacy

- 17(2) A disclosure of personal information about a third party is deemed to be an unreasonable invasion of the third party's privacy if:
 - (e) the personal information relates to the third party's employment, occupational or educational history;

(g) the personal information describes the third party's source of income or financial circumstances, activities or history.

Determining unreasonable invasion of privacy

- 17(3) In determining under subsection (1) whether a disclosure of personal information not described in subsection (2) would unreasonably invade a third party's privacy, the head of a public body shall consider all the relevant circumstances, including but not limited to, whether:
 - (d) the disclosure may unfairly expose the third party to harm;
 - (h) the disclosure may unfairly damage the reputation of any person referred to in the record requested by the applicant.

Subsection 59(1) of The Freedom of Information and Protection of Privacy Act provides that you may make a complaint about this decision to the Manitoba Ombudsman. You have 60 days from the receipt of this letter to make a complaint on the prescribed form to:
